Please note that this is forbidden strictly and **CETRA** will take this matter further if this will continue.



## DO NOT FEED PIGEONS & SQUIRRELS

On the Estate



There has been an increase in pigeons, squirrels and now even <u>rats</u> on the estate. Please could Residents refrain from leaving food waste around the estate or feeding pigeons and squirrels. Not only is this considered as littering but it is also in breach of your tenancy and lease agreement.

Once vermin or rodents become accustomed to feeding on the estate, they multiply rapidly which seems to be a current issue with the rats on our

estate. Large amounts of any rodents (including pigeons, foxes, squirrels and rats) can result in an unsightly environment and health risks due to the pest excrement.

We have also received reports from Residents about squirrels accessing/trying to access their homes through the windows of their property

CETRA would like to advise that the biggest reason residents attract squirrels, rats, foxes and pigeons on the estate or even to their homes, is because they feed them.

Feeding squirrels may cause them to lose their natural fear of humans. If squirrels come to

expect food and it isn't provided, they may become aggressive in seeking it out.. Squirrels can also carry fleas, mites and other parasites that could be transferred to others if those bugs linger on the feeder.

We kindly ask residents to be vigilant and report to us any sightings of anyone seen feeding any vermin on the estate as well as anyone seen anyone dumping rubbish especially food waste bags in the communal areas, so that we can take the appropriate action.



#### A CLEAN ESTATE IS A HAPPY ESTATE

It has come to our attention that some residents on the estate are not disposing of rubbish bags correctly and are disposing of them on the floor of the bin chamber instead of in the bin itself.

Ultimately, the bags that are placed loosely on the Cedars Estate are a health and safety risk, an eyesore and also attracts vermin.

We understand that on some occasions the bins could be full and there is no space to dispose of the rubbish. On those occasions CETRA would like to advise Residents to use bins in adjacent blocks instead of disposing of the rubbish on the floor of the bin chamber.



We have also noticed that some residents who live on the first floor are leaving their bags on the communal landing. CETRA would like to remind you that once you take the rubbish bag outside of your property, it has to go straight to the bin and not be left anywhere in the communal areas. As mentioned in the article above we are currently dealing with a rat infestation on the estate so please could those tenants responsible for doing this refrain from doing so.

#### PLAYGROUND & BASKETBALL COURT UPDATE

As some of you may know we recently upgraded our Playground by replacing the large playground unit, the swings and the wet pour so we hope the Children of our Estate are making the most of our renewed Playground.



Unfortunately CETRA have an on-going issue at present whereby nonresidents of the Estate are using our Playground. The Playground is frequently used by the children of surrounding schools (especially Macaulay opposite School Playground). We have contacted the school regarding this matter on several occasions but unfortunately doesn't seem to stopping the children and their parents from coming onto our estate and using our Playground's facilities.

To deal with this issue we have considered several solutions and we kindly ask Residents who use the playground to let us know if they are happy with any of the below suggestions; or to provide us with their own suggestions if not listed below

- Keep playground closed during certain times (before/after school finishing)
- Keep Playground closed at all times and provide those Residents who wish to use the playground with a key to access the playground themselves. To do so the Resident would need to contact the CETRA Office to obtain a key
- Change the locking system of the Playground & Basketball Court where residents
  would need to use the code that cannot be shared with anyone from the outside of
  the estate in order to access the playground/basketball court
